Contemporary *malaise* concerning Metaphysics. The problem of metaphysical method. Need to consider also theology, in so far as this claims to be knowledge of "transcendent reality". Metaphysics to be described as an analogical form of thinking. Non-metaphysical use of analogy. Proportionate and Illustrative analogies. Metaphysical uses of analogy. Hypothetical, Projective, Deductive, Coordinating and Existential types. Need to examine relation of thought and reality. Suggested meaning for terms "reality" and "existence".

Problem of "data" of experience. Use of word "sensa". Criticism of direct realist and representationalist views and of causal theory of perception. Criticism of idealist view; does it do justice to distinction between perception and thought? Nature of percipient awareness. Phenomenalism.

Adverbial and accusative modes of sensation. Criticism of Whitehead's view; and of Köhler's theory of "isomorphism". Perceptual experience as involving both responsive and symbolizing modes of activity.

Phenomenalist, realist and idealist accounts of nature of scientific knowledge. Criticism of "mathematical idealism" of Cassirer and Eddington; and of Cassirer's distinction of mythical, analogical and scientific thought. Analogical character of scientific models. Interrelation of symbolic forms with empirical procedure.

CHAPTER V

ANALOGIES IN RELIGIOUS SYMBOLISM PAGE 96

Contrast between symbolic forms of science and religious analogies. Is there a universal form of mythical thinking? Myths as symbolic dramas of forms of psychical response to the world. Archetypal images. Religious meaning of the "transcendent". Symbolic expressions of response to reality grasped as "other" and "absolute". Reasons for ambiguous character of religious imagery. Analogical ways of expressing religious relationship.

CHAPTER VI

REVELATION AND FAITH 115

Transition from symbolic expression of religious response to its interpretation in theology. Analogical character of theology obscured by development of natural theology in last two centuries. Reasons for neo-orthodox reaction against natural theology. Kierkegaard's attack on mediating ideas. "The endless qualitative distinction between God and man." Barthian view of "faith" and "revelation". Reasons for doubting that this escapes epistemological problem underlying metaphysics. Analysis of meaning of faith; its distinction from judgments of probability. Total and partial assertions.

Ways of relating and distinguishing theology and philosophy. The significance of theological tradition and of philosophical freedom. Relation of both to history. History as events and as interpretation of events. Analysis of notion of "meaning" in historical events. The historical and the practical past. Theological and philosophical interpretations of history.

ANALOGIA ENTIS 169

Do the analogical concepts of theology express a unique metaphysical relation? Classical attempt to uphold this in Thomist philosophy of the Analogy of Being. Exposition of this. Criticism. Our divergences from the Thomist view.

Recapitulation, and formulation of our own view of how metaphysics is analogical. Development of metaphysical views by analogical
